### Tax Information

Declaring municipal and prefectural taxes and a special consultation of income tax  
Please declare your taxes as soon as possible. Based on the information from the last year, a declaration form is sent to those who may need to report your taxes this year. Please check the booklet *Heisei 29 Nendo Shiminzei Kenminzei No Shinkoku Ni Tsuite* (About declaration of municipal and prefectural taxes) for the changes in the guideline. The booklets are distributed in February through your local resident's association.

When: February 16<sup>th</sup> (Thu)-March 15<sup>th</sup> (Wed) (except on weekends) from 9am-12pm, 1pm-5pm

Where: City Hall Main Building 2<sup>nd</sup> Floor, Residence Tax Division (Shiminzeika)

City Hall Branch Offices

Details: Those who were registered residents of Fukui city as of January 1st, 2017.

Declaration of taxes is still required for those who did not have any income from January to December, 2016.

The following people do not need to declare taxes:

-Those who already filed final tax return

-Salary employees and recipients of pension whose employers have submitted payment reports to city hall.

\*However, those who were employed or unemployed in the middle fiscal year and/or those who can get any tax deduction in municipal/prefectural taxes need to declare for taxes.

\*If you do not declare, you will not be able to receive a deduction of income tax or national health insurance tax. Also an income/taxation certificate will not be issued.

Please note that not declaring your tax will prevent you from receiving a deduction of income tax or national health insurance tax or issuing income/taxation certificate.
